- I recognise that I will be invited by FIBA for a personal interview and a test and that I will have to pay a fee of CHF 250, 00 for the test.
- I recognise that I will have to pay an annual fee in accordance with Article H.5.5.2 of the FIBA Agent Regulations as long as I hold a FIBA Players' Agent Licence.
- I intend to participate in the personal interview and the test in the month of:

- I recognise that in accordance with Article H.5.5.1 of the FIBA Agent Regulations I will have to attend a refresher seminar organised by FIBA every two years to verify that the requirements for the issuing of the licence are still met.
- I recognise that the FIBA Internal Regulations, in particular the FIBA Agents Regulations as amended from time to time are applicable to my relationship with FIBA as a Players' Agent and I further recognise that I am subject to disciplinary sanctions by FIBA in case of breach of any of these regulations.
- I recognise that in accordance with Article H.5.4.14 of the FIBA Agent Regulations in the event that the national federation of my home country enacts regulations governing the activities of agents, I will be obliged to prove to FIBA that I am the holder of a valid licence issued by that federation.
