NOTE:

For the sake of consistency, 'team A' is always the (initial) offensive team, while 'team B' is the defensive team. A1 - A5, B1 - B5 are players on the court; A6 - A12, B6 - B12 are substitutes.

Please circle the correct answer – only one mark per answer

	STATEMENT	ANS	WER
1	Team A is awarded a throw-in mistakenly, instead of 2 free throws. Team A passes the ball on the court and scores a field goal. The error is discovered at this time. The error shall be corrected.	YES	NO
2	With 20 minutes before the game, the both coaches agreed to exchange the baskets that they will attack but they shall still keep the team benches assigned to them by rules. The referee shall agree with this exchange.	YES	NO
3	A4 has been in the restricted area for almost 3 seconds when A5 releases a shot for a field goal. The ball touches the backboard and it is rebounded by A4 who is still in the restricted area. This is a 3-second violation.	YES	NO
4	The ball becomes live when referee enters the restricted area to administer a free throw.	YES	NO
5	For a screen to be considered legal, the only criteria for a player who is screening is that he must face the opponent when contact occurs.	YES	NO
6	During team A alternating possession throw-in, a violation is committed by A3 thrower-in. Team B is awarded a throw-in as a result of the violation. Team B shall be entitled to the next alternating possession arrow throw-in.	YES	NO
7	A5 is designated on the scoresheet as team captain (CAP). A10 enters the game as a substitute for A5 and to replace A5 also as captain on the playing court. While A5 is on the bench, coach A receives a disqualifying foul. Team A does not have a designated assistant coach. A10 shall now take over the duties and powers of coach A.	YES	NO
8	With 2:02 remaining on the game clock in the 4th period, team A scores a field goal. The ball is now rolling on the floor. Timer shall stop the game clock now.	YES	NO
9	A3 with the ball in his hands is closely guarded by B2. B2 must give sufficient distance for A3 to pivot.	YES	NO
10	A player falls to the floor while holding the ball. This is a travelling violation.		NO
11	The referee is tossing the ball on the jump ball. One of the jumpers does not jump but leaves immediately his jumping position to catch the tapped	YES	NO



	ball. This is legal.		
12	B6 asks for substitution in the 2nd period. Next A2 scores a field goal. The scorer erroneously sounds the signal for the substitution. The official blows his whistle and interrupts the game. Shall the substitution be granted to B6?		NO
13	With 1:03 remaining on the game clock in the 4th period, B1 commits a technical foul. A5 free throw is not successful. Team A is granted a timeout. The game shall be resumed with team A throw-in at the throw-in line in its frontcourt.	YES	NO
14	Team A has control of the ball in its frontcourt when a double foul between A1 and B1 in the frontcourt is called with 7 seconds remaining on the shot clock. The game shall be resumed with a team A throw-in and with 24 seconds on the shot clock.	YES	NO
15	Following an unsportsmanlike foul, a throw-in shall be administered at the centre line extended, opposite the scorer's table. The thrower-in can take a step towards the frontcourt and pass the ball to his team-mate in the backcourt.	YES	NO
16	Team A has 8 seconds to move the ball to the frontcourt. When the 8 seconds period expires, the ball is in the air above the frontcourt. This is legal.	YES	NO
17	The captain of the team is the person to sign the scoresheet in case of protest.	YES	NO
18	The basket which a team defends is its own basket.	YES	NO
19	A2 is dribbling from his backcourt and ends his dribble with holding the ball and straddling the centre line. A2 passes the ball to A1 who is also straddling the centre line. This is legal.	YES	NO
20	A10 requests to enter the game as a substitute for A4 at the next opportunity. During the next dead ball, but before an official has beckoned A10 to enter the playing court, a technical foul is committed by A4. The A4's foul be considered as a player's foul.		NO
21	A2 ends his dribble with both feet in the air. A2 comes to a legal stop by landing on both feet simultaneously. A2 shall be entitled to take a pivot step.		NO
22	After 50 seconds of a time-out have elapsed, the timer sounds his signal. Timer sounds his signal 10 seconds later to indicate the end of the time- out. B6 requests the substitution for B1. The request shall be granted.		NO
23	The ball touches the back of the backboard. The ball has gone out-of-bounds.		NO
24	With 1:27 remaining on the game clock in the 4th period, A3 causes the ball to go out-of-bounds in team B backcourt. Team A is granted a time-out. Following the time-out, team B throw-in shall be administered at the throw-in line extended, opposite the scorer's table in its frontcourt.		NO
25	A1 scores a field goal or a last free throw. Team B is granted a time-out. Following the time-out, B1 thrower-in places the ball on the floor after which B2 who is also out-of-bounds takes the ball. This is legal.	YES	NO
